A 50% deposit is required to hold your date. This will be paid when the contract is signed. The remainder will be due on the date of the wedding.

POLICIES & OTHER INFORMATION

SCHEDULING A SESSION/ BOOKING A WEDDING

Portrait appointments should be scheduled several weeks in advance to ensure availability. Session fees are due prior to the beginning of the session. If you are unable to keep your session appointment, please notify us at least 48 hours of the original session time.

Weddings and events require a non-refundable retainer of at least 50% of your package fee to be paid when the contract is signed. The remainder will be due on the date of the wedding or event.

PRE-SESSION CONSULTATION

For most portrait sessions and events other than weddings, a consultation via email or phone is sufficient. We will discuss locations, outfits, what to expect from us, and answer any questions you may have prior to your session.

A one-hour consultation is included with your wedding package and we strongly suggest it occur at your wedding location(s). If you live or work in the Seattle area, an in-person pre-wedding consultation is advisable. The consultation provides us the opportunity to meet and get acquainted and you'll be able to review our work, ask questions, and discuss what to expect from us during your wedding. If you live outside the Seattle area, the pre-session consultation may be done via email or phone conversation.

PROOF PREVIEWS

Proofs will be ready 2 weeks after your session/wedding/event. You'll have the option to view your proofs online or in person via a laptop presentation. Online previewing is an excellent option as your family and friends may enjoy the opportunity to view the proofs as well. Your online gallery will be available for at least 3 weeks for weddings and events and 2 weeks for portrait sessions. This is a great opportunity to give friends and family a chance to see and order photos for themselves.

ORDERS

Ordering is done via the online gallery or in person during the laptop presentation. All orders are prepaid and delivered directly to you.

PAYMENT

Allen Welsch Photography accepts cash and check. Credit card payments (Visa, MasterCard, & American Express) can be accepted as well as PayPal.
